This Memorandum of Understanding (MoU) is entered between **Nutoras Foods Private Limited**, a company incorporated under the Indian Companies Act, 1956 having its registered office at 86, Mistry Industrial Complex, Cross Road A, MIDC, Andheri East, Mumbai - 400093, and represented by its undersigned of the ONE PART;

And **S. SINHA COLLEGE**, Aurangabad, Bihar represented by undersigned of the OTHER PART;

Whereas **Nutoras Foods Private Limited** and **S. SINHA COLLEGE** shall be hereinafter jointly referred to as the “Parties” and singularly as a “Party”.

The Parties have decided to establish industry-academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU). **Nutoras Foods Private Limited** and **S.SINHA COLLEGE** agree on the following activities:

1. **Nutoras Foods Private Limited** will provide support for designing the course curriculum at **S. SINHA COLLEGE** which would be relevant for industry. To achieve this, senior officials from **Nutoras Foods Private Limited** will work in close collaboration with faculty members of **S. SINHA COLLEGE**. Once a curriculum is designed and courses relevant to the industry are offered at **S. SINHA COLLEGE**, senior officials from **Nutoras Foods Private Limited** will share their knowledge and experience by the way of taking sessions, participating in seminars and other academic activities of **S. SINHA COLLEGE**.

2. **Nutoras Foods Private Limited** will offer to provide internship for the students of **S. SINHA COLLEGE** at its project sites to enable them to get practical exposure and learning from interaction with members of **Nutoras Foods Private Limited**'s project teams.
3. **S. SINHA COLLEGE** shall provide students and arrange for placements on campus for the representatives of **Nutoras Foods Private Limited** by providing student details and mediating all communications.

Each party shall appoint a nodal officer to periodically review and identify ways to strengthen cooperation between them.

This **MoU** will effect from the date signed by the representatives of the parties. It will remain valid for three years and may be continued thereafter after suitable review and agreement. Either party may terminate the **MoU** by giving written notice to the other party. Once terminated, neither **Nutoras Foods Private Limited** nor **S. SINHA COLLEGE** will be responsible for any losses, financial or otherwise, which the other party may suffer. However, **Nutoras Foods Private Limited** and **S. SINHA COLLEGE** will ensure that all activities in progress are allowed to be completed successfully.
